## Woman faces neglect charges

■ Her 11-year-old daughter and 9-year-old son were found alone without food in a cluttered Scotts Valley apartment.

Scotts Valley police arrested a single mother of three earlier this week after discovering two of her children had been left hungry and unattended in a dirty apartment for several days.

Police went to the Blake Lane apartment Sunday after an anonymous caller gave them detailed information about the family.

"The place was pretty dirty and they were obviously neglected," said Sgt. Bruce Lindsay of the Scotts Valley police department.

"This isn't the Ruby Pointer story," he added, referring to

three small girls found grunting in a squalid apartment in Santa Cruz several years ago.

Lindsay said the youngsters did not appear to be malnourished, although the refrigerator held only rotting vegetables. Nearby residents told police the pair had been known to go door

## Woman charged with neglect after 2 kids found home alone

Neighbors told officers they often fed the children and invited them in because they were obviously lonely and had no one to provide for them.

"It was not an isolated incident," Lindsay said. "We've learned the kids were left alone quite a bit."

Atkinson apparently stopped by her apartment briefly on Sunday, Lindsay added, then left again without caring for the children.

Scotts Valley police left a note on Atkinson's front door, asking her to contact them. She was arrested Monday when she went to the Scotts Valley police department.

She was booked at the county

jail and released on her own refrom Page 1BSSN JUL 3 1 THE cognizance on Wednesday. Atkinson, also known as Cherie Berry, turns 29 today.

> If convicted of felony child neglect charges, she could be sentenced to a maximum of six years in state prison. If the district attorney files misdemeanor charges, Atkinson could face up to one year in the county jail if convict-

Atkinson could not be reached for comment. A neighbor, who declined to be identified, said the children were left alone "all the time."

Lindsay said the children are doing fine in foster care.

A spokeswoman for the county's child protective services agency confirmed the children were in foster care, but declined to release any additional information.
