SC United Way Says Thanks To Volunteers

cruz County United Way's accomplishnent of raising a record \$544,283 in last ear's fall-winter fund-raising effort uner the direction of Campaign Chairman E. Reese Davis, his campaign team and housands of volunteers. The 1981 goal was 540,000.

Funds raised will be allocated to 20 uman service organizations, including hree agencies who were granted mempership in 1981-824 Big Brothers/Big Sisers, I-You Venture and Citizens for a Better Nursing Home Care/Ombudsman.

Early in the program in the Sun Room at the Cocoanut Grove, Darrow paid pecial tribute to the "pillars of our organization, the Salvation Army and Red Cross, who have done such an outstanding ob in helping the people of Santa Cruz County who have been in need during our recent storm and disaster." Her comments were greeted with roaring applause.

Other county organizations that will penefit from the UW effort are: Family Service Association (two branches), Parents Center, Skills Center - Association for the Retarded, Suicide Prevention Center, Visiting Nurse Association, Boy Scouts, Girl Scouts, Camp Fire, YMCA, Catholic Social Service, and YWCA (2).

Aside from Ritchey, the 1982 officers include: president-elect Ray Bourret, vice

This is our night to say thanks," said Darrow, and there were plenty of thank yous to go around for the 1981 campaign that raised 18 percent more than the \$466,471 total in 1980.

Pillsbury/Green Giant captured the corporation of the year award with Darrow estimating the firm's employee and coporate campaigns were responsible for about \$70,000.

Wayne Jordan was named campaign volunteer of the year for coming up with the idea of a "parking lot sale" of canned goods and frozen foods in the Pajaro Valley which earned \$22,000. It also was mentioned that the majority of the top 10 company contributors came from the agricultural community in Pajaro Valley.

Other award winners were: Watsonville Press with the highest per capita donation for companies with 26-100 employees, Avera Corp. with the highest percentage and dollar increase in that category. Allstate Savings and Loan has the highest per capita for companies with less than 25 employees, and Sunbay Farms won highest percentage and dollar increase in that category.

Also given special recognition were "loaned executives," employees of companies which actually "loaned" a total of 55 weeks of employees' time for the United Way cause. Their efforts were a vital part in raising \$375,000 or 70 percent of the 1981 campaign, said Darrow. The loaned executives were: Stella Bartle of Salz Leathers, Leo Cohan of Lockheed, John Crawford of PG&E, William Hansen of County Bank, Norrine Kettler of Pacific Telephone, Janet McEntee of Green Giant and Hubert Smith of F.W. Woolworth.

Both Darrow and Ritchey praised the quality of the UW staff under executive director Larry Donatoni.
