

County Building Permits Total 306,142 For 3-Week Period

County building valuation reached a total of \$306,142 for the first three weeks of this month.

Building Inspector Russell Scott reported that home construction started off with a rush, with the first week seeing 15 permits being issued for new dwellings. During the December 1-5 period total building valuation was \$175,935 for 40 permits.

The following week, December 8-12, building dipped to \$63,446 with only 22 permits, then climbed a little in total valuation, to \$66,759, although only 21 permits went out for December 15-19.

Five new dwelling permits were issued from December 15-19, while four persons received new home permits for December 8-12.
