## Cowell Campus Site Funds Released

Funds For New UC Campuses



## **Brown Signs** Order For

Governor Edmund G. Brown today signed an order releasing \$3,000,000 in state funds for development of the three new campuses of the University of California with the bulk of the funds assigned to the Cowell site in

Santa Cruz.

Of the \$3,000,000, some \$2,576,000 are scheduled for use on the Cowell ranch site including \$2,-011,825 for purchase of 1918 acres from the S. H. Cowell Foundation and another \$460,175 for site development.

The San Diego county campus will receive about \$300,000 for site -development with \$100,000 slated for the Irvine ranch site in

orange county.

The funds were appropriated by the 1960 legislature under terms of a budget augmentation, introduced by Assemblyman Glenn Coolidge of Santa Cruz. They were held in reserve until the university selected sites for the three new lected sites for the three new

Under the budget proposal, the funds required both the approval of the governor, the state director of finance and the university

board of regents.

At the regents' meeting in April in Los Angeles, the board formally requested the release of the funds so final approval by the regents is automatic. John Carr, state director of finance, also signed the order today.

For the Santa Cruz campus: \$2,011,825 for purchase of 1918 acres from the Cowell foundation; \$44,000 to be spent for 32 acres of land now used as a water tank site; \$60,000 for the purchase of five acres of land not owned by the Cowell Foundation to round out the cam-

pus site; an additional \$460,175 for planning, surveys, grading, planting and utilities at the Santa Cruz site. For the San Diego campus: \$300,000 for site development. For the Irvine ranch campus in

Orange county: \$100,000 for site development.

Assemblyman Glenn Coolidge, who has been active in getting the funds released, expressed his pleasure at another key step in the development of the Cowell ranch site for a university campus.

Coolidge said the funds would accelerate the planning and development of the Cowell site so that it can be readied to relieve the enrollment demand on the

Berkeley campus.

City and county officials have been meeting regularly with university officials regarding local commitments for the campus development with the work primarily centered at present on the determination of campus boundaries and aerial surveys to provide adequate contour maps for the area.
