City considers repair, improvement budget

SANTA CRUZ - Councilmembers are getting closer to decisions on projects in a \$6.7-million repair and improvement budget for 1983-84.

Some projects will overlap the year, but their budgets are included in the coming fiscal year's account. Final decisions are expected June 28.

The council met Tuesday and Wednesday in budget discussions and in the capital improvements. section tried to stretch a few dollars and delay one or two projects. They expressed dismay over the unwanted delay of one major project.

The council was told that repair of Soquel Avenue Bridge - still missing one-third of its width from the January 1982 storm — will take another 18 months. Councilman John Laird responded, "That's outrageous.

"Isn't there somebody in a responsible position

we can beat up?" Laird asked.

Staff members quickly pacified him before federal officials could catch word of his ingratitude.

The federal government is paying the \$330,000 cost.

Public Works Director Larry Erwin said the work is expected to be completed by the fall of 1984 "at the earliest."

The council may put some city money into resurfacing five tennis courts at Santa Cruz High School, but the city will pay no more than half the \$75,000 Cost and the street and the street street and the street street and the street street street and the street stree

It has been asked to pick up \$50,000.

To participate, the council is considering dropping a \$45,000 conversion of a maintenance building at Harvey West Park into a "sports activity center."

Councilman John Mahaney asked for a cost figure on sweeping more of the city's streets, saying that some of them "are getting horrible."

Erwin said he'd bring in costs of quarterly or half-year sweeps to see if the city can afford them.

Councilman Spiro Mellis said he's going to raise the issue of the implementation of the Livable

"I know I'll be accused of politicizing the issue," he said. Our section of the control of the control

Councilwoman Mardi Wormhoudt said she's interested in having the city explore purchase of the lot by the YWCA building, with Mellis responding, "I'm not in favor of that at all."

He said the Louden Nelson Center park is only three blocks away and Mahaney said he wasn't so sure that there were enough kids in the neighborhood to support buying the lot by the YWCA building.

He was assured there were plenty of kids.

Councilman Joe Ghio was disbelieving that the Ocean Street project, between Dakota Street to Soquel Avenue, would finally been done.

"It's been going up in cost every year," he said of the \$979,000 project that will widen the road and place a median strip.
