We're growing too fast; Sum shut 9/23/7/ back to drawing board

Santa Cruz County supervisors were wrangling Tuesday over how much population growth should be allowed in the county next vear.

The board is obligated under the terms of the county's growth management law - Measure J to establish an annual growth rate that constitutes the county's "fair share" of the overall growth in the state.

Supervisors learned today that the assumptions that they had been operating on in previous years Director Kris Schenk said that the figures from the 1980 census reveal that the population of the county is

at least 12,000 above what the projections made at the time Measure J was drawn up indicated it would be.

Consequently, Schenk said, the board faced the choice of either cutting back sharply on the annual growth rate it authorized or of raising the population goal it wanted to reach by the year 1990. Under its original projections, the goal for that year was to be 218,000. But, because that projection was made as a result of some inaccurate assumptions, Schenk suggested it would be more weren't accurate. Planning, realistic to calibrate the growth rate to accommodate a population by 1990 of closer to 230,000.

accurate information supplied by the 1980 census. this would mean a growth rate of about 2.1 percent over that period would be allowable. The rate allowed by the board this year was 2.4 percent, slightly higher than the 2.2 percent of 1980.

Because of complaints from the public that the system has resulted in a large backlog of would-be homebuilders waiting in the building permit line, as well as uncertainty from year-to-year as to what the situation might be, Board Chairman Gary Patton urged the board to set a flat 2 percent growth rate for the rest of the decade.

Patton conceded that the Schenk said that with question of whether this

board could lock in a growth rate when Measure J speaks of setting such rates annually would have to be decided by the county counsel.

That's one of the reasons the matter was put off until the afternoon. It was not certain the board would act then either, because a

number of other questions were hanging around. including the assertion of i the county Builders Exchange - an organiza- h tion of builders and their suppliers — that state law requires the county to take into account "regional" as well as just county housing r. needs
