**GOPLiberals** Agree To Back John S. Cooper

Washington (A).-Senate Republican liberals agreed today to back a slate headed by Sen. John Sherman Cooper of Kentucky for the party leadership in the senate.

In a 2½-hour meeting, eight GOP insurgent senators agreed also to support Sen. Thomas Ku-chel of California for whip, or as-

sistant leader.

The group decided to meet again next Tuesday. Sen. George Aiken of Vermont said a decision would be made then whether to contest the re-election of Sen. Styles Bridges of New Hampshire as chairman of the GOP policy committee and of Sen. Leverett Saltonstall of Massachusetts as chairman of the Conference of All GOP Senators.

## **Unruh Explains Favored Program**

Sacramento (A).—Assemblyman Jesse M. Unruh, who probably will head the powerful assembly ways and means committee next year, favors a "half-and-half" tax program - spread between consumer and income taxes.

He said today it appears certain the 1959 legislature—faced with a near-empty treasury when it convenes Monday-will enact California's first cigaret tax. On top of that, he suggested a boost in beer taxes.

However, whether the city can enforce its site supervision decisions still seems to be in doubt legally, according to recent discussions before the city council.
