Thursday, he named Philip Pennypacker, 56, a San Jose defense attorney, and Vincent Chiarello, 46, a Mill Valley civil litigator, to the seats left vacant by the retirements of Judge Robert Foley and Judge Marliese Kim.

Judges aren't the only ones Davis' sights. If he moves pickly, Davis also could

quickly, Davis also could name Almquist's successor on the board of supervisors before leaving the governor's office. Almquist, 55, was nearing the end of his second four-year term as a supervisor. He had applied for a seat on the bench, but until McAdams'

bench, but until McAdams elevation there was no vacan-cy. So in August, Almquist announced his intention to Almquist seek a third term next year.

Now a new incumbent will get to defend the 5th District seat, which covers Scotts Valseat, ley and the San Lorenzo ley.

Declining to toss out the names of any potential suitors for an appointment by Davis, Almquist said an effor would be made "to try to ge

e made "to try to get consensus" from the "variety of good some among the "candidates." Among the known hopefuls are Don Dietrich, 45, a former sheriff's deputy who is now a field representative for v a field representative for Operating Engineers Local 3, which represents Santa Cruz County deputies; Mark Stone, a Scotts Valley lawyer; and Larry Prather, a member of the Boulder Creek Water

Board. "There's been a lot of

names floating around," said Dietrich, who sees it "boiling down maybe to four or five people." Barbara Sprenger, a San Lorenzo Unified School District board member, was mored to be interested but said Thursday she is not — at least not now. "I would be very interested in doing the job someday," she said, "but this isn't the right time, with everything going on in the school district here."

With Almquist moving to the bench, Scotts Valley Mayor Randy Johnson, a Republican, is the only announced candidate for the 5th District supervisor's seat.

Almquist said he got the word from the governor Tuesday morning during a board of supervisors meeting but was told to keep mum about it. "I fooled 'em all," he

said. "It was great."

His private swearing-in today will be followed next Friday by a public ceremony. "I start work Tuesday," he said.
