C Of C Still Works Hard On UC Campus

Greater Santa Cruz Chamber of Commerce is still working hard to persuade University of California that Santa Cruz is the spot for a university branch.

Gordon Sinclair, chairman of the University of California Site committee, presented a progress report Thursday to the chamber board of directors.

Chamber representatives have contacted the Cowell Foundation trustees concerning land owned near High street which seems adapted for a college campus. The site committee is also sending letters to the university board of regents and state officials explaining the advantages of locating the university branch in Santa Cruz.

It was also reported that the chamber is writing to some 15 leading nation-wide magazines in an intensive effort to get feature coverage of the Santa Cruz area.

Chamber manager David B. Owen reported that 20th Century Fox is considering the use of the Soquel area as a movie site. Although plans are completely tentative, filming of the outdoor drama would employ some 600 to 700 movie extras.

Owen also presented a summary of industry in the Santa Cruz area explaining that during the past year nine new industries located here.
