## **Board Okays Preliminary New Courthouse Drawings**

Preliminary plans for a mod-ern one-story courthouse with its back to the San Lorenzo river at the site of the old Garibaldi hotel are expected to be completed in November by the San Francisco architectural firm of John Lyon Reid and partners.

Clearance for starting the preliminary drawings was given by the board of supervisors this week after viewing a bird's eye view of the redesigned courthouse, which formerly had the law courts separated from the main building.

A \$32,000 federal loan to work up the preliminary plans has been granted the county.



The law courts in an earlier plan were ticketed as a separate structure but have been moved into the one-floor main building to allow for more flexibility and additional parking.
