Soquel Ave., opening Burdick's Television and Appliance in 1955, then built an 11,000-square-foot store at the same address in 1974, demolishing the old store to provide parking.

Burdick's serviced televisions when they were expensive to buy but that changed when the cost to buy a new model became less than the cost of repair.

"Now TVs, there's no money in it," said Burdick. "Costco makes money on memberships.

He's seen the number of appliance manufacturers shrink over the years, too.

"There used to be 60 to 70, now there are five," he said. "It's a little monopolistic."

Burdick took over in 1977 after his father retired, expanding to five locations in Santa Cruz and Monterey.

"The earthquake knocked me out of business," he said, recalling the 1989 destruction of Haber's and Ford's, where he sold appliances.

After filing for bankruptcy reorganization, he sold 902 Soquel Ave. to Western Appliance of San Jose in 1996 and went to work for his former competitor.

executive officer of Western Appliance, said he and his partners decided to sell the Santa Cruz property after Burdick gave his retirement notice.

"He's irreplaceable," Moir said.

"Most of the things we bought, we bought at Western," said Santa Cruz resident Eileen O'Shea. "We always had a good experience.

Western Appliance, started by Jacob Neiderauer in 1873 in Bakersfield, has expanded and contracted with the times.

At one point there were 10 locations. Come March, there will be one.

"We will service the market from here," said Moir from his San Jose store. "We really loved our association with Santa Cruz."

The retail environment has changed with the arrival of big-box competitors such as Best Buy and Home Depot and online sales, he noted, questioning whether the so called "brick and mortar" stores make sense right

Bei-Scott Co., a local firm that purchased 902 Soquel Ave. for \$1.247 million this month, plans to lease the building.
