UC To Put Seismographic Facility In Santa Cruz

A broad plan to create six new seismographic facilities in Central California and improve the instrumentation of existing ones will be implemented shortly by the University of California as a result of the negotiation of a \$400,000 contract between the university and the air force office of scientific research.

The new stations will be connected by means of a telemeter system with the university's central seismographic station on the Berkeley campus.

Purpose of the new stations and the system of communication is to provide information rapidly to the Berkeley station on the location of the epicenters of relatively small earthquakes below magnitude 5.

The contract also provides for three mobile, truck-based seismographic units, which can be quickly dispatched to the area of the epicenter in order to collect information on the nature and position of aftershocks following smaller earthquakes.

The scientists in charge of the new project are Dr. Perry Byerly, professor of seismology and director of the University's seismographic stations, and Dr. Don Tocher, research seismologist.

According to the researchers, the plan, when fully implemented, will permit the first definitive studies of aftershocks associated with small earthquakes. The studies may also be of value in helping scientists to distintguish clearly between small natural earthquakes and man-made exploquakes and man-made

The six new seismographic stations will be located at or near Mt. St. Helena, northeast of Santa Rosa; Pt. Reyes, in Marin county; Santa Cruz, Los Banos, in Merced county; Coalinga, in Fresno county; and Jolon, near the southern edge of Monterey county. The contract also provides construction of new for the construction of new underground vaults for the seisunderground vaults for the seismographic instruments of the station on the Berkeley campus. The subterranean station, which will be the nerve center of the telemeter network, will be located in an isolated section of Strawberry Canyon, above the campus proper, at least 600 feet from the nearest road.

The present Berkeley station is situated in the center of the Berkeley campus, where local traffic and artificial noises render the instruments partially inlocal

When the entire network is in operation, the outlying stations will automatically transmit earthquake information to the new Berkeley station for recording. The advantages of this arrangement, according to the scientists, are several:

(1) There will be no need to man the outlying stations.

(2) Only one timing system (at Berkeley) is required.

(3) The telemeter system will permit the immediate detection of instrument troubles at the out-

The seismologists said that the Central California coastal area is an ideal locale for such a system, being as subject to earthquake activity as any area in the country. As an example, they said that within this area they recorded 103 separate epicenters in 1955, 118 in 1956, and 113 in 1957.
