The William Wrigley, Jr., company, world's largest chewing gum manufacturer, will build a \$3,000,000 plant in Santa Cruz, it was announced yesterday in Chicago by Philip K. Wrigley, chairman of the board of directors.

Negotiations were completed late Friday with representatives of the Southern Pacific company for the purchase of 5.3 acres on Mission street and West Cliff drive along the Ocean-

shore highway.

Actual construction is expected to start by early summer, Wrigley indicated. The plant will employ about 300 persons with an annual payroll of \$1,250,000. It will produce \$8,000,000 worth of chewing

gum a year.

The Wrigley company decided to locate in Santa Cruz after making a survey of numerous west coast cities during the past year. It will be the first Wrigley manufacturing plant to be built west of the Mis-

Thursday afternoon the city council met in special session to approve the extension of the main industrial sewer line from Mission and King streets (at Linda Vista market) to the Wrigley property in order to provide adequate sewage for the huge plant. Cost is esti-mated at \$12,000 by City Manager Neal Smith. Smith said he regard-ed the expenditure as an excellent

investment for the city.

Mayor George N. Penniman said that the council acted in emergency session to allow the Wrigley company to complete its purchase plans

"The City of Santa Cruz welcomes the Wrigley company," Penniman stated, "And will do everything possible to aid the company in its plans for a Santa Cruz production plant."

Holcomb indicated that the Wrigley company desired a west coast plant to meet growing demands for the Wrigley products in the western states and for export from the west coast.

"The migration to the west dur-ing the past decade brought about our decision to construct a west coast plant in order to improve dis-tribution of our products to all parts of the western United States, Holcomb stated.
