## Mall vision clouded

Downtown Vision Sends Court leader quits 8-17-90 planning group

SANTA CRUZ New Downtown Association President Ron Prilliman has resigned from Vision Santa Cruz, charging that the planning group has

been ineffective in helping get rebuilding started. "There has been a 'study it' mentality," Prilliman said Thursday. He is the owner of Cymbaline Records and has been very active in Vision Santa

"I don't care about the big picture anymore. I want something to happen. I want buildings in the ground," Prilliman said.

Prilliman said he was not surprised that Ford's Department Store Vice-President Hal Hyde has announced Ford's will rebuild in Watsonville but at least for the moment — not in Santa Cruz.

Prilliman said there has been no clear vision developed by Vision Santa Cruz, a 36-member mix of business owners, politicians and residents. "After 11 months, everything still is very much up in

What is the holdup downtown? "If city government had gone out and demonstrated a willingness to cooperate, we'd have new buildings by now, Prilliman said.

Mayor Mardi Wormhoudt disagreed.

"I think we've given clear direction," she said. If there are obstacles that haven't been communicated, she said, property owners should speak up so the city can deal with them.

"But, we can't build their buildings ""m," said Wormhoudt, who is also a member of Vision Santa Cruz.

Vision Santa Cruz has come up with general recommendations which were requested by the City Council and is now looking at more specific issues. Prilliman said he does not know of one property owner who is near breaking ground, except maybe the new owners of the Gottschalks

Department Store property.
But Charles "Chop" Keenan said he and partner
Jack Bariteau are still at the preliminary stages of putting plans together.

And although he would only say he and Bariteau have an option to buy the old Pacific Western Building across the street, the Sentinel learned Thursday that the deal is actually in escrow.

He also charged that the city, and now Vision Santa Cruz, is doing too much talking about social problems downtown. "John Laird's group did a wonderful job a year or so ago, they defined all the problems. What we need now is implement a plan," Prilliman said. There are a number of options, ranging from stricter sentences for chronic drunks to leasing the downtown to the merchants so trespassing laws can be enforced.

'If the council would just make the statement 'We're going to do whatever it takes to solve the problem,' you'd have people lining up to do their developments."
