## Preferred Library Sites For SLV And Live Oak Identified

Preferred sites for future libraries in the Live Oak and San Lorenzo Valley areas are located adjacent to the Live Oak Senior Citizens Center, and either in Ben Lomond or Boulder Creek, county supervisors said Tuesday.

The board, however, was careful to indicate it was only expressing preferences and not making prematures decisions for the city-county Library Board.

The Public Works Department identified 11 possible sites in the Live Oak area, and five in the valley; however, the board quickly asked that a single site in the Felton area be removed from consideration.

Supervisors' Chairman Ed Borovatz said he was less than eager to seek a location that would "remove the present library from the Faye G. Belardi Memorial building in Felton."

The board also asked that the Library Board be concerned with a site in Ben Lomond that is just off Highway 9 and would pose traffic problems. The site is located on the easterly side

of Highway 9 at the intersection with Ben Lomond Toll Road.

The preferred Live Oak site is at the north side of Capitola Road between 17th Avenue and Chanticleer Avenue. It lies just east of the senior center. Its estimated market value is \$95,000 and has 47,000 square feet. It is designated as site 3.

Other Live Oak sites:

Site 1 — The northwest corner of Capitola Road and 17th Avenue; it has 32,000 square feet and is valued at \$72,000.

Site 2 — The north side of Capitola Road at El Dorado Street; it has 85,000 square feet and valued at \$85,000.

Site 4 — The southwest corner of Capitola Road and 30th Avenue; it has 92,600 square feet and valued at \$70,000.

Site 5 — The northeast corner of Brommer Street and 38th Avenue; it has 55,000 square

feet and valued at \$125,000.

Site 6 — The northeast corner of Brommer Street and 30th Avenue; it has 1.9 acres and valued at \$60.000.

Site 7 — The south side of Brommer Street and Brommer Way; it has 39,200 square feet and valued at \$50,000.

Site 8 — The southwest corner of Brommer Street and El Dorado Avenue; it has 60,000 square feet and valued at \$75,000.

Site 9 — The west side of 17th Avenue, south of and adjacent to the railroad tracks; 40,000 squre feet and valued at \$30,000.

Site 10 — The west side of 17th Avenue at Alice Street, near Portola Drive; 68,000 square feet and valued at \$100.000.

Site 11 — The northwest corner of Portola Drive and 30th Avenue; 53,550 square feet and

valued at \$120,000.

In San Lorenzo Valley, the following sites were identified:

Site 1 — Southwest corner of Highway 9 and Park Avenue, Boulder Creek; 25,000 square feet, value at \$45,000. Site 2 — Southeast corner of Grove Street and Boulder Street, Boulder Creek; 26,600 square feet and valued at \$21,000.

Site 3 — Westerly side of Fillmore Avenue, Ben Lomond; 22,000 square feet and valued at \$30,000.

Site 4 — Easterly side of Highway 9 at intersection of Ben Lomond Toll Road, Ben Lomond; 28,000 square feet and valued at \$35,000.

Site 5 — North side of Hihn Steet, Felton; 25,000 square feet and valued at \$20,000.

Values are estimated and for parcels only.
