A Great Crowd Gathers On SC Plaza -It's Sunday, November 11, 1918

Tomorrow is Veterans Day.
But the national observance
began 45 years ago with a different name — Armistice Day ferent name — Armistice Day— and the Armistice itself, follow-ing World War I, was erroneously announced three days early-on November 8.

Regardless of the initial confusion about the date and the change in name in 1954, the meaning of the day has not changed. Because Sunday, November 11, 1918, was a day of great rejoicing all over the nation.

The "war to end all wars" had ended at 6 a.m., New York time, by official proclamation. Americans went wild with joy.

In cities all over the United States parades were formed on the spur of the moment, factory whistles blasted out the good news, cannons boomed, flags waved, people laughed — and went wept.

Headlines of the New York Times were heavy with black ink and exclamation marks:

Armistice Signed, End of War!
Berlin Seized By Revolutionists, New Chancellor Begs For Order; Ousted Kaiser Flees To Holland, Berlin Troops Join Revolt! Son Flees With Ex-Kaiser, German Dynasties Being Wiped Out, Throngs Demand Republic!

The United States had de-

The United States had declared war on Germany on April 6, 1917, and the first American troops landed in France on June 26 of the same year: 116,516 of these men were killed; another 4500 were listed as missing.

Germany had declared war on Russia three years earlier, on August 1, 1914, following the assassination of Archduke Francis Ferdinand.

On November 8, 1918, United ress had sent out a premature spatch from Paris, reporting that peace terms had been set-

On November 11, the good news of armistice again traveled fast over the nation, even without benefit of radio or TV. And this time it was true. California's governor, W. D.
