Sales down in first half of '91

State figures for the first six months of 1991 show that sales were down from 1990 in Santa Cruz County, as they were across the state.

The State Board of Equalization report on statewide sales for the first three months reveals what the board calls "the most severe decline in taxable sales in the last three decades, and the first drop since the 1982 recession."

Sales statewide dropped by 5.2 percent, or more than \$3 billion, from the first quarter of 1990. In Santa Cruz County, sales dropped 6.3 percent.

The second quarter, which has not yet been broken down by city, had a smaller decline in sales. The statewide decline was 4.6 percent in the second quarter; Santa Cruz County's was 2.6 percent.

Analysts said that while the first three months were dire, they weren't as bad as the worst of the 1982 recession when compared in "real" dollars — that is, when adjusted for inflation. Actual volume of sales decreased 8.6 percent in first quarter 1991, compared with 9.9 percent in the worst quarter of 1982.

Watsonville fared the worst in Santa Cruz County, with a 13 percent overall decline. Santa Cruz had a 7 percent decline, and Capitola a 0.5 percent decline.

Watsonville and Santa Cruz were both hurt by a decrease in auto sales of about 29 percent. Auto sales in Capitola, with its growing auto plaza, increased by close to 0.2 percent.

Service stations statewide showed an increase in sales, due in part, analysts said, to the Persian Gulf war that helped drive up gasoline and oil prices an average of 15 percent. Gasoline consumption decreased, however, by 3.2 percent, to 3.2 billion gallons over the three-month period.
