Belgard named to LAFCO as board picks commissioners

Santa Cruz County supervisors have appointed Board Chairman Ray Belgard to the Local Agency Formation Commission.

The selection was one of a long list of appointments to boards and commissions for supervisors. The appointments were proposed by Belgard and routinely approved by the board yesterday.

Belgard will hold one of five seats on LAFCO, an inter-agency

group that oversees annexations and incorporations. He replaces Robley Levy, who lost her bid for a fourth term as supervisor in November.
