Many people, including myself, used to think and some still believe that the road signs that we see on the highway are paid for by the California State Automobile Association. In fact, many people believe that this is what a part of the money they pay the association for membership goes for. But the following is a copy of what is recorded in Volume 16, Page 7 of the Records of the Board of Supervisors under date of December 4th, 1922, which shows this belief to be a mistake Monday, December 4, 1922. On motion of Supervisor Wyman, duly seconded by Supervisor Moore, the following resolution is adopted:
BE IT RESOLVED by the
Board of Supervisors of Santa
Cruz County, State of California, in regular meeting assembled this 4th day of December,
1922, that the California State
Automobile Association, Incor-

1922, that the California State Automobile Association, Incorporated, is hereby authorized and ordered to erect not to exceed 250 of its standard metal enamel road signs on the roads and highways of said Santa Cruz County.

Said signs are to be of dia-

Said signs are to be of diamond shape, baked enamel, on 18-gauge Armco Iron, 23 inches x 29 inches in size, front point, with dark blue lettering upon a light yellow lemon background, and are to be attached to a 4-inch x 4-inch 12 foot surfaced redwood post which is to have no less than three coats

ground, and are to be attached to a 4-inch x 4-inch 12 foot surfaced redwood post which is to have no less than three coats of paint, and which is to be set in the ground from three to three and one-half feet.

It is specifically understood that after said signs have been installed the California State Automobile Association, Incorporated, will maintain and keep them up indefinitely at its own expense and supply without cost to Santa Cruz County, a new sign to replace any mutilated or destroyed sign upon notification from any Supervisor of said County of the necessity of such replacement.

The said Board of Supervisors of Santa Cruz County hereby agree to pay the said California State Automobile Association, Incorporated, the sum of Four Dollars (\$4.00) per sign for the total number erected, not exceeding 250 signs, upon presentation of proper claims for same by the Californit State Automobile Association, Incorporated, upon completion of the work of installing the signs hereby ordered.
