Charity appeals-for-pay 'border on disgrace'

The practice of paying solicitors whopping percentages of money raised in the name of charity "borders on disgrace," Santa Cruz County Sheriff Al Noren said this morning.

The 42 charities that raise money by phone solicitations in Santa Cruz County received an average of 22 percent of the money after paying for expenses

— usually outside firms hired
for solicitations — Noren said.

"I don't think people realize" how little goes to the charities, said Noren, who called a press conference after receiving the financial statements of the companies. Such statements are required by state law of companies that solicit by phone.

Noren suggested that people

who want to donate give directly to the charity of their choice, rather than through a paid solicitor.

Noren included the county
Deputy Sheriffs Association in
his criticism. "No question
about it. I've told them," Noren
said. The group, which raised
\$90,022 last year, \$18,004 of
which went to charity, is not
under Noren's control.

Kim Allyn, a director of the Deputy Sheriffs Association, said the group is in the second year of a contract with TBS Productions to solicit by phone, but doesn't intend to renew it.

"Our membership feels (such solicitations) are not in the best interests of the association," Allyn said. Members are voting on a proposed raise in dues to

make up for what the group now gets from solicitations, Allyn said.

Noren provided information from the state Attorney General that 72,000 charities registered in California raise about \$33 billion a year. Many of these groups are not headquartered in California.

Information on charitable groups is available from the Attorney General's office at 916-445-2021.
