## 'Senseless' Slaying Of SC Man

By TOM HONIG Sentinel Staff Writer Another Santa Cruz killing.

Fred Perez, 72, 511 Lighthouse Ave., who comes from one of the oldest pioneer families in Santa Cruz, was shot and killed this morning while doing yardwork near his

A Police Lt. Chuck Scherer described the slaying as "a senseless, ambush slaving with no motive." He said that the killer fired the shot at Perez from a distance of about 75

Police have a man in custody in connection with the slaying, which took place at 8 a.m.

Herbert William Mullen, 25. 1541 McClellan Road, Felton, was apprehended by police minutes after the killing as he reportedly was on his way out of town in a blue Chevrolet station wagon. Patrolman Sean Upton nabbed the suspect as he was driving on River Street

near Coral Street, and he gave up without a fight, police said. Police Capt. Dick Overton said that Mullen has not made any statements except to ask police to observe his civil

A neighbor reported the slaying to police. She said that she saw a station wagon leaving the scene of the killing at the

intersection of Lighthouse Avenue and Gharkey Street moments after hearing a sound resembling a gunshot.

She said that she looked over and saw Perez lying on the

Perez had reportedly been moving dirt with a shovel before he was shot. The lot on which he was working is located at the corner of Lighthouse Avenue and Gharkey Street. The house on the lot is occupied by renters.

A sheriff's deputy who was returning home following the graveyard shift at work spotted the man down in the yard, and thinking that he was perhaps

the victim of a heart attack, he said to the man, "you'll be all right." The deputy said that the man at that point was still

· Police responding to the call arrived moments after the shooting, while still more police gave pursuit to the getaway

A witness at the scene of the arrest said that police discovered a rifle in the car which Mullen was driving.

The Perez family is one of the oldest in the local fishing business. Malio Stagnaro, a good friend of Perez, said that the man's grandfather and

three uncles preceded Perez in the retail end of the business.

Stagnaro said Perez served in China during World War I. After the war, he fought professionally under the name of Freddie Bell for three years.

After he retired a couple years ago, Stagnaro said, he "took things easy" with his wife Margaret. "He worked around the yard, or went fishing. He had no enemies in the world. Everybody like Fred, he was really a fine person. Everybody on the wharf today is in a state of shock - all the boys are really shook up."

A 16 - year - old door - to door peddler has been charged with the rape slaying of an elederly Capitola woman.

Wilfried Willie Brown, a California Youth Authority parolee, is being held at the Santa Cruz County Probation Center charged with first degree murder and rape of Mrs. Ida Anderson Stine

Capitola Police Chief Martin Bergthold issued a statement which indicated the intense investigation which incriminated Brown showed that he acted alone and had "flipped out" turned psychotic - at the time of the crime. Bergthold said Brown's mental state was not drug - induced.
