Not yet had the building at the extreme right, the 2½ story Deuglas House, been remodeled into the beginnings of the great landmark Sea Beach hotel, which held sway as a leading California hostelry from 1888 until it was destroyed by fire in 1912.

Pioneer Resort

Directly above the reflecting pool, the Seaside Home was perhaps first of the tourist resort spots on the hill. It was in existence as early as 1865, operated and perhaps built by James R. Richards.

By the middle of the Eighties it was being operated by Mrs. Frank Lewis, who had been lit-Frank Lewis, who had been hetel Patty Reed of the well known Donner Party saga. In the middle Nineties she went to manage the new Hotel Capitola, later taking up residence in Twin taking up residence Lakes

When the former Beach Hill property of Mrs. Lewis, together with the Liddell holdings, was purchased by Mrs. D. D. Colton. wife of an early-day railroad tycoon, the place became known as "The Cabins," entered from Second street at Drift Way. Later and for many years, it was the Grace estate.

In 1882 A. H. Douglas, an artist from Chicago, purchased the place, then giving it his name, which it remained until the Sea Beach came into prominence.

D. K. Abeel, former editor and publisher of the Kansas City Journal, when he took over in 1886, began the expansion of the hotel which brought into being the imposing but sprawling three-story edifice that brought fame to this city by the sea. John T. Sullivan, John R. Chace and J. J. C. Leonard were three who were prominently identified with the hotel, each playing his part in making the vast and picturesque place of outstanding importance to Santa Cruz and the tourist world.
