Morrow Files Damage Suit Seeking \$50,000

A \$50,000 damage action has been filed in the superior court by Bernard (Barney) Morrow against Audrey Fordyce and Glen Sliter, both valley residents.

According to the complaint, the defendants during the last year prepared and caused to be circulated in the valley printed matter dealing with the personal life of the plaintiff, who operates Brookdale Lodge, at Brookdale.

The complaint states that the act was "unlawfully, wickedly and maliciously done" with the intent to injure the plaintiff's reputation and standing in the community.

He is seeking \$25,000 general damages and \$25,000 punitive damages. Filed with the complaint is a copy of the circular allegedly distributed in the valley.
