No Juvenile Hall Ph **Before Accord**

By Wallace Wood Sentinel Staff Writer Supervisor Vincent Locatelli promised last night to bring ac-Locatelli tion on a new \$500,000-juvenile hall "to a standstill" until leading property owners on north Ocean street can agree on a pos-sible location for the half.

Locatelli and other county department heads, including Probation Officer James Solo-mon, faced about 50 friendly including mon, faced about 50 friendly but determined persons at a meeting at Pedemonte hall last night to explain the reasons behind the choice of a site in the Italian Gardens area.

The great majority of persons, including homeowners from Paradise Park and the Graham Hill road area, were against locating the hall at any one of three sites picked by the juvenile justice commission, county judges and county supervisors judges and county supervisors last week. All three sites are on north Ocean street.

Only one, contractor Werner asper, spoke strongly in favor favor Jasper, spoke strongly in lavor of locating the children's detention home there. He was bal-anced by the most vocal spokes-man for the opposition, Rupert Fallis, whose mother-in-law Fallis, whose mother-in-law owns one proposed hall site.

Locatelli suggested that Fallis and Jasper, who lives at 2125 North Ocean street, meet with other interested property owners to discuss a "compromise" site.

Jasper suggested a location just north and almost behind the Odd Fellows cemetery, on property picked by the county as the number two site choice.

Fallis charged that the loca-

tions picked by the co would cause property valu-plummet "catastrophically" the county if a

hall were on one of them, and threatened a legal battle "so long that you will have to draw new juvenile hall plans by the time you have the property."

If we put it down by the river, we will be free to go ahead and develop the rest of our area."

Joseph Alcantara of 56 South Circle drive, off Graham Hill road, attacked the cost figures prepared by the county on the Ocean street properties, set at from \$55,000 to \$85,000. "I was on the committee that looked for sites for the new Dominican hospital, and anyone who thinks this land is worth less than \$10,000 an acre is a dreamer."

Alcantara suggested that the county take another look at the Shaffer property west of Santa Cruz, even though the projected cost is more than \$300,000 for development and use of a hall. "Just keep looking," he said. keep looking, About 10 acres will be needed for a hall site.

Mrs. Flora Rowland, operator of the Valhaven guest home, 2044 Ocean street, declared that many residents will live in fear of escapes from the hall, "since these boys will know that none but elderly people live here, with no man around the place."
