## Frazier Pleads Innocent; Trial Set

John Linley Frazier, indicted on five counts of murder by the Santa Cruz County Grand Jury, this morning pleaded innocent to all five counts.

Frazier's attorney, James Jackson, entered the pleas for Frazier after first reserving the right to change the plea to innocent by reason of insanity and to request a change of venue at a later date.

A tentative trial date was set for Jan. 25. Frazier, smiling slightly at times and often staring at District Attorney Peter Chang, remained silent throughout the short session in Judge Charles Franich's Superior Court.

Frazier, 24, a Soquel resident, was indicted by

the Grand Jury for the slayings of Dr. and Mrs. Victor Ohta, their two sons, Taggart and Derrick, and Dr. Ohta's secretary, Mrs. Dorothy Cadwallader. on Oct. 19.

Jackson had requested a continuance rather than a trial date, but Judge Franich yielded to Chang's arguments favoring a definite date.

Chang later said he insisted on a trial date to ease the scheduling of more than 20 prosecution witnesses.

Jackson said the trial date does not hinder defense motions, but will make more paperwork necessary. He later returned to Franich's court to request the Grand Jury transcripts to be sealed. The request was granted.

Asked if Jan. 25 was an unusually long time for a trial to be set, Chang said, "It's pretty quick. Usually it is nine months or a year after the occurrence before a murder case gets to trial."

The victims had been bound with silk scarves, blindfolded, shot and dumped into the swimming pool at the Ohta home. The \$250,000 mansion was set afire, apparently to call attention to the killings, according to Sheriff Doug James.

Firemen found the access roads to the house (Continued on Page 2)

### France Bids Adieu To De Gaulle

PARIS (AP) - France said goodby today to Charles de-Gaulle.

In the magnificence of Notre Dame Cathedral, yet with the simplicity he ordained, world leaders joined thousands of Parisians at an austere Mass concluded with the Magnificat.

DeGaulle's body was not at this Church of Our Lady, where lage where he lived and died. And there, a few hours later, it was committed to the soil of France.

Great crowds had gathered at the village of Colombey les Deux Eglises, but a simple burial in a country churchyard replaced the military pomp that DeGaulle had rejected for the fi-

nal ritual.

Around the world, admirers of France's greatest leader since Napoleon called at French embassies and consulates to sign condolence books, Officials, diplomats and private citizens attended memorial services in
