7-8-77 Davenport Power Plant Possibility

The area from Davenport to the City of Santa Cruz is being considered as a possible location for a fossil fuel or nuclear power plant, Sandy Hillyer, State Coastal Commission staff member, told Central Coast Commissioners this morning.

Hillyer said the area is under a "C" designation in the staff report which would restrict development on the seaward side of Highway 1, but leave open for further study the eastern side. The state commission is expected to make final determinations in December.

Commissioner Gary Patton, a Santa Cruz County supervisor, said that an Aug. 23 workshop planned in this area by the state commission should have public involvement, noting, "The Davenport area was slated as a nuclear site earlier, and they (PG&E) still have a continuing interest there, I understand."

Hillyer said the workshop on Aug. 23 would involve "a cross-section of interests, environmentalists, utilities and city and county planning staff members . . . by invitation."

Commissioner John Bakalian, a resident of Capitola, said that one of his companies had a contract with "Mothers for Peace," a group that was concerned with expansion of the Diablo Canyon nuclear plant. He wants fossil-fuel plants and nuclear plants considered in separate categories, as nuclear plants have the problem of waste disposal.

Hillyer said the only other site in the Central Coast Commission area (Santa Cruz, San Mateo and Monterey counties) that has been freed from an "A" designation (no plants allowed) is Moss Landing, where the PG&E fossil-fuel plant is located.

He said the state commission was not certain of its authority to determine if expansion is a possibility at that location, but that if it is found to have that authority, in subsequent expansion of the Moss Landing plant it will have to determine "there is no

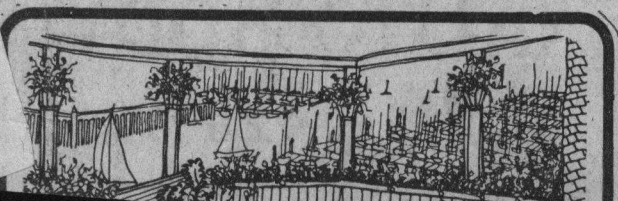

significant environmental effect and the expansion is consistent with use of the land."

Hillyer said the state staff's firm recommendation to the state commission is expected Sept. 23, and Central Coast Commission Chairman Mary Henderson said she would call a meeting of the regional commission between that time and the November hearing of the state commission on plant sites along the coast.

Hillyer said the final state recommendations in December would be forwarded to the State Energy Commission.
